- The Councillor elected as Chair must sign a Declaration of Acceptance of Office form before taking the Chair.
- Where vacancies exist on the Parish Council after an election, the new Parish Council may co-opt without formal notice - the election process being deemed to have been notice to anyone wishing to stand.
